Terms & Conditions: -

EMD - Rs. 10000/-

1. Only dry & dead trees is to be cut.
2. The wood to be cut in the boiler size 6" dia to 8" dia & length from 3 to 4 feet.
3. Above 6" dia the wood will be cut in lengthwise 2 pcs.
5. Loading & Un-loading of wood in the boiler house by the Tractor-Trolley.
6. Party can use mill power saw free of cost on his risk & cost for above work.
8. Penalty 2% to 10% max. Will be imposed if the work becomes delay.
9. The weight of dry wood verified by Boiler incharge, Security person & Store Keeper.
10. The Contractor will work as per labour law.
11. Quantity may be increased or decreased & varies up to $\pm 10\%$.
12. Work will be complete within 20 days.
13. The party will be responsible for any mishappening of his labours.
14. Payment: After submitting the bill verified by the Chief Engineer.
15. F.O.R. Sugar Mills, Meham.
16. PAN No. and Bank Account No. are necessary for contractor.
17. Taxes will be deducted as per rule.
18. The work is to be completed according to the instruction of the mills Chief Engineer.
19. If you supply in any Haryana Coop. Sugar Mills on rates lower than this mills, you will intimate the same and refund the difference immediately within 15 days, if you fail to do so and this mills comes to know regarding same, then you will have to refund the double of the difference.
20. That in case any dispute or difference about the work contract arises be the parties, the same will be decided the managing director of the mills, Arbitrator, whose decision shall be final and binding on the parties.
